Overview

We most strongly support this proposed scheme.


The concept, vision, and implementation have our full support. We would like to take this opportunity to praise how accessibility, mobility, space for recreation, formal, informal, social, and active, together with space for nature are all considered and consciously blended. This not only represents best practice but also ambition and vision.

Notwithstanding comments below on suggestions for minor improvements, we hope to see this scheme implemented without significant change.

Possible improvements and critical analysis.

We are particularly happy to see the accessibility Masterplan (see below) which considers the movement of people through the park as well as ensuring accessibility to the park for all.

However, we are concerned at the link circled in blue below is not suitable for the large volumes of commuter cyclists who will be expected to use this link.




As outlined in the map below there are two options of suitable widths and surfaces for commuter cyclists (marked in Blue). However, both are indirect and have two sharp turns. As a result, it should be expected that the majority of commuter and leisure cyclists using this link will either not "discover" these paths or will opt for the more direct routes (marked in orange) avoiding a sharp double u-turn.

While it is appropriate that these paths (marked in orange) are accessible for leisure cyclists who are there as a destination moving at low-speed the use of these paths by commuters who may be late for work and moving at higher speeds is not desirable either for those computers or for the pedestrians using the paths so we would suggest that there is a slight redesign in those areas to

A Eliminate the sharp turns on one of the paths (marked in Blue) suitable for commuter cyclists and

B Signage indicating the direct cycle route be erected to encourage direct cyclists to use the more suitable path.





Importance of retaining the Old Railway to Marina & Monaghan Rd links during construction

The old Railway Greenway linking the Mahon employment cluster to the city centre is not only an important recreational asset but is also a vital economic transport link. It enables the movement of a large number of commuters between employment in the Mahon cluster and accommodation in the city centre area as well as employment in the city centre area and residential areas in the wider Blackrock and Mahon area. It is of Strategic importance that this route remains open during construction work and that traffic is not diverted onto the Blackrock Road which is unsuitable for many cycle commuters.

We would therefore ask that the phasing of works ensures that there is continuity of access between the Marina, Monaghan roads, and Blackrock station via the old railway line.
